

DATA PROTECTION AND PRIVACY NOTICE

1. Who does this Data Protection and Privacy Notice apply to?

This Data Protection and Privacy Notice (Notice) applies to anyone who:

- is a member of the Rolls-Royce Owners' Club of Australia SA Branch Inc ("**the Club**") whose objects are to encourage the ownership, good keeping and restoration of Rolls-Royce and certain Bentley motor vehicles (eligible motor cars); and
- is a visitor who interacts with the Club to or make enquiries of the Club, including when you:
 - o visit the Club website;
 - o attend or make enquiries about Club run events either online, over the phone or in person;
 - o agree to participate in user experience research or to provide feedback to the Club; or
 - o sign up to receive communications from the Club.

This Notice is to be read in conjunction with the Club Data Protection and Privacy Policy (**Policy**).

2. What types of personal data will be processed by the Club?

We process personal data that is received directly from you through a variety of forms, and the types of personal data processed by the Club will depend on the nature of your interaction with us.

- For visitors and Club Members, the personal data will include:
 - o usernames, passwords and other registration details that you provide when registering to use our website or other services;
 - o details of your visits to, and use of, our website, Wi-Fi and other online services, including different parts of those services you access during your visits, your IP address, and the date and time of your access.
- For Club members the personal data will also include the details you directly provide to the Club in your membership application form and any supporting documents that the Club requests as part of the application process, which the Club may also share with the Rolls Royce Owners' Club of. Australia Ltd (RROCA)

This may also include details such as your contact details and details of your interactions with the Club as well as your communication preferences.

Your personal data is created, stored and transmitted securely in a variety of paper and electronic formats. This includes databases that are shared across the Club, RROCA, and members.

Where you provide the Club with the personal data of other people, you are encouraged to inform them that:

- you are disclosing that information to the Club
- the information will be retained; and
- they can access that information by contacting the Club's Privacy Officer.

3. Why do we need your personal data, what is our legal basis for processing it, and how will we use it?

For Club members, the personal data processed by us, or processed on our behalf, is needed for the purposes of carrying out certain functions for which the Club is responsible. These include to:

- (a) collect and disseminate information regarding eligible motor cars
- (b) establish, maintain and publish a register of members and their eligible motor cars for the Club's members and contribute this to the RROCA which publishes an aggregated record of each state Rolls-Royce Owners' club's register (Chassis Plate); and
- (c) contribute to the RROCA which publishes and disseminates a national magazine containing articles of interest to the RROCA's' members and equivalent overseas clubs (Praeclarum).

We consider that the lawful basis for the processing of your personal data is that it is necessary for the pursuit of the functions of the Club.

For visitors and enquirers, the personal data processed by us, or processed on our behalf, is needed for the purpose of facilitating your interaction with the Club and to help the Club improve your experience. The specific purpose for processing personal data will be communicated to you at the time that we first interact with you about that matter. If you choose not to provide your personal data, it may not be possible for the Club to provide you with the specific information or assistance you have requested.

We consider that the lawful bases for the processing of your personal data as a visitor or enquirer of the Club is that it is necessary for the pursuit of the legitimate interests of the Club (e.g. to respond to your enquiry and to facilitate your visit to a Club event) and where it is necessary in order for us to fulfil our obligations to you (e.g. when you sign up and attend events).

We will obtain your consent for specific use of your personal data not covered by this Notice or where that personal data includes special category data, which we will collect from you at the appropriate time. You can withdraw your consent to our specific use of such data at any time.

In addition to the purposes set out in the Policy, our specific processing purposes of your personal data as a member of the Club and how we use it include:

- to correspond with you;
- to attend to day-to-day administrative matters such as distributing our Club magazine (Southern Spirit) and that of the RROCA (Praeclarum) to you;
- to inform you about RROCA or Club events and activities;
- for benchmarking, analyses, quality assurance and planning purposes;
- to compile statistics and conduct research for internal reporting purposes;
- to seek feedback of your experiences as a visitor or enquirer of the Club;
- to fulfil and monitor our responsibilities to comply with legislative reporting requirements;
- to prevent or detect fraudulent activity;
- to contact you for the purpose of seeking your feedback; and
- to use the information as otherwise permitted by the law.

We are committed to the integrity and safeguarding of personal data as set out in the Policy. We take all reasonable steps to ensure that the personal data processed is managed in accordance with the Club's Retention and Disposal Policy.

4. Who will the Club share my personal data with?

We may share your personal data with a range of third parties, including the following:

- the RROCA;
- contracted service providers which the Club uses to perform services on its behalf (such as, banks, mailing houses, logistics, IT service providers and caterers for Club or RROCA events); and
- in the event of an emergency, police, medical or hospital personnel, civil emergency services, your legal representative or nominated emergency contact person, or other person assessed as necessary to respond to the emergency.

For general enquiries, we will not share your information with third parties outside the Club unless doing so is required for the purposes of fulfilling your request;

In the event that personal data is disclosed to third parties, such disclosure will be limited to the extent necessary to fulfil the purpose of such disclosure.

5. What are my individual rights?

In addition to your rights to access and correct your personal data and lodge a complaint relating to how we handle your personal data as set out in the Policy, if the GDPR applies, 1 you may, under certain conditions, have the following rights available:

- to object to any processing of your personal data that we process on the lawful basis of legitimate interests, unless our reasons for the underlying processing outweighs your interests, rights and freedoms;
- to withdraw your consent where we have processed any of your personal data based on consent;
- to object to direct marketing (including any profiling) at any time;
- to ask us to delete personal data that we no longer have lawful grounds to process; and
- to object to the use of automated decision making.

6. What security measures are in place on the Club website?

The Club website has security measures in place against the loss, misuse and alteration of information as defined in the Club's IT Security Policy.

A login name and password are required to visit secure areas. This is to ensure that the information is displayed only to the intended person. You should ensure that your password is kept securely and cannot be discovered by anyone else.

The Club website and its Facebook group page may have chat rooms, forums, on-line teaching environments, message boards and or/news groups available to their users. Please remember that any

information that is disclosed in these areas becomes public information and you should exercise caution when deciding to disclose your personal data.

7. Links to other sites

Our policy discloses the privacy practices for the Club. While we provide links to other websites, once you leave this website, you will be going to websites that are beyond our control and you are subject to the privacy policy of that other website.
